Scope and Content

The materials in FOIA 2007-1758-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2007-1758-F contains photographs from the White House Photograph Office. The first part of the collection includes contact sheets containing photographs of the Clinton's hosting a private dinner for Rev. Billy Graham and his wife in the private residence on 2/3/1993. The second part of the collection includes contact sheets containing photographs from the National Prayer Breakfast on 2/04/1993. The Clintons and the Gores attend the Prayer Breakfast at the Washington Hilton. Participants at the Breakfast include, Billy Graham, Sen. John Kerry, Rep. Ted Stevens, Rep. Bill Emerson, Secretary Mike Espy, and others. The third part of the collection includes contact sheets containing photographs from the Funeral of President Richard Nixon on 4/27/1994. The Clintons arrive at the Richard Nixon Library and greet former President Bush, Billy Graham, and others. The fourth part of the collection includes contact sheets containing photographs from the National Prayer Breakfast

on 2/02/1995. The Clintons and Gores attend the Prayer Breakfast at the Washington Hilton. Participants at the Breakfast include, Billy Graham, Martin Lancaster, Alice Lancaster, General Carl Mundy, Andrew Young, Secretary Richard Riley, and others. The fifth part of the collection includes contact sheets containing photographs from the Oklahoma City Memorial Service on 4/23/1995. The Clintons attend the Memorial Service for the victims of the Federal Building bombing in Oklahoma City, OK. Billy Graham makes remarks at the service to the victim's families and the guests at the Fair Grounds Arena in Oklahoma City. The President and First Lady greet Billy Graham and others backstage at the arena. The sixth part of the collection includes contact sheets containing photographs from the George H.W. Bush Library Dedication on 11/06/1997. The Clintons attend the Bush Library dedication ceremony at Texas A&M University in College Station, TX. The Clintons greet former President's Bush, Carter, Ford, and the former First Ladies at the Library. The Clintons tour the exhibits at the Library. The Clintons greet Billy Graham at the Library. The seventh part of the collection includes contact sheets containing photographs from the National Prayer Service on 2/05/1998. The Clintons and the Gores attend the Prayer Breakfast at the Washington Hilton. Participants at the Breakfast include, Billy Graham, Rep. Bobby Scott, Dorothy Height, General Henry Shelton, Sen. Daniel Akaka, Sen. Connie Mack, and others. The eighth part of the collection includes contact sheets containing photographs from the Time Magazine Anniversary Dinner on 3/3/1998. The Clintons greet Billy Graham at his table during the dinner.
