## Supplemental Guidance: Revenue Codes Ineligible for Reimbursement in the Early Retiree Reinsurance Program

## **November 11, 2011**

As outlined in the Claim Layouts provided on www.errp.gov, institutional claims must contain an ICD principal procedure code, revenue code, or procedure code on each service item detail line. One, two, or all three codes may be present. Plan Sponsors should note, however, that if a procedure was performed as part of an institutional claim, the applicable procedure code must be included in the Claim List.

As outlined in program guidance released on September 28, 2010, ERRP will generally credit toward the cost threshold, and reimburse, items and services that Medicare would cover. Consistent with this benefit standard, items and services associated with the revenue codes listed below are generally considered ineligible for ERRP and will cause a detailed Claim List to be rejected. These revenue codes describe such categories of items and services as custodial care, personal comfort items, and routine dental services, among others.

Plan sponsors including the below revenue codes as part of an ERRP reimbursement request will not be reimbursed for, or get credit toward the cost threshold for, costs associated with such claims unless the sponsor successfully demonstrates upon the adjudication of an ERRP appeal that the relevant items and services could be covered by Medicare under any setting. As a reminder, an adverse reimbursement determination, such as a determination that a submitted revenue code is excluded, may be appealed by the Plan Sponsor pursuant to ERRP regulations at 45 C.F.R. Part 149, subpart F and detailed in guidance published on October 3, 2011.

CCIIO may issue additional updates to the lists of excluded codes. Downloadable files containing the latest list of excluded CPTs/HCPCs, and ICD-9 and ICD-10 codes can be found on the Regulations and Guidance page on the ERRP website, <a href="www.errp.gov">www.errp.gov</a>.
