Dear Financial Aid Administrator:

The office of Federal Student Aid, U.S. Department of Education, would like to share some updates to assist you in working with students. This letter supplements one we sent in September. If you did not receive the September letter, you may read it at www.FSAPubs.gov (under "Latest News").

Publication Updates

This winter, we will introduce a four-page document called *Federal Student Aid for Adult Students*. This publication reassures adult students that they can receive federal student aid regardless of age or credit rating. It offers tips about going to or returning to college, ways to reduce education expenses, and resources for finding more information about aid, careers, admissions testing, accreditation, and more.

As we mentioned in our September letter, we have transitioned the *Counselors and Mentors Handbook* to be an online-only publication. The 2012–13 edition is available in PDF at www.fsa4counselors.ed.gov.

Ordering Publications

Page 4 of this letter explains how to use www.FSAPubs.gov to order free publications. Note the request to provide your e-mail address at the site so we can communicate with you more effectively. You also can change your postal address or other contact information at that site.

FAFSA Enhancements

As you might be aware, *FAFSA on the Web* at www.fafsa.gov allows applicants to access their IRS tax information and have it automatically inserted into the FAFSA. The 2012-13 FAFSA will include a brief series of questions to determine whether an individual is eligible for IRS data retrieval. (Examples of someone who is ineligible would include someone who amended his/her tax return or filed separately from his/her spouse.) Only eligible applicants will be able to retrieve IRS data, saving time and confusion. The 2012-13 FAFSA will offer IRS data retrieval beginning February 1, 2012.

Your Guide to FSAPubs

The Federal Student Aid Publications Ordering System (FSAPubs) is **your source for free bulk shipments of Federal Student Aid publications**. Visit FSAPubs today to update your account and place orders:

1. You can find the FSAPubs website at **www.FSAPubs.gov**. At the site, you will be asked for your OPEID, your school's identification number that appears on the mailing label of the envelope in which this letter arrived. If you don't know your OPEID, call 1-800-394-7084 to find out what it is. If you do not have Internet access, you may call that same number to place orders for publications.
2. At the FSAPubs site, type your OPEID into the box in the middle of the home page and click on the "LOGIN" button. If you have not visited the site in the past couple of years, you will see text on the screen asking you to validate your address. Follow the directions on the screen.
3. Even if you have visited the site regularly, we encourage you to click on the "Account Management" link on the left side of the page and choose "Add/Modify Shipping Information." On the next screen, click on "Edit" and modify any information that is incomplete or incorrect. You should do the same for your "Institution Address." **Please SUPPLY YOUR E-MAIL ADDRESS at the site so we can notify you of any new publications, training, or emergency information.**
4. To order publications, click on "Publications" at the left side of the screen and browse the list or search for specific items. Enter the quantity you need and follow the directions to place your order. Remember, all of our materials are free.
