




Percentages compared to Total Senior Leader population (1,355)












White Collar General Schedule Equivalent Gx* Pay Plans (Appropriated Fund)
















General Workforce Demographics - Ethnicity (Appropriated Fund)






General Workforce Demographics - Gender (Appropriated Fund)






General Workforce Demographics - Age (Appropriated Fund)














CSRS Optional Retirement Eligibility (Appropriated Fund Employees) As of 07/31/2012 & 07/31/2017








Avg Retirement Age & Avg Years of Service at Retirement (Appr Fund)












Local National Employees by Component






