The Bancóldex Capital Program was launched in 2009, to promote the development of the Private Equity and Venture Capital industry in Colombia








- Since 2009, Bancóldex has invested USD 37 MM in four funds, with commitments around USD 400 MM

PE/VC industry in Colombia 20 funds seeking for investment opportunities



Compound annual growth of 73% of capital commitments


Infrastructure funds represent 33% of total capital commitments
