FY 2009 in Review



The Grants.gov Program Management Office (PMO) partnered with grantor agencies and concentrated on system adoption, utilization and customer satisfaction.

During FY2009 Grants.gov experienced unprecedented growth due to the American Recovery and Reinvestment Act of 2009 (ARRA) also known as the \$787 billion stimulus package, which created numerous federal grants. In FY2009 grant application submissions totaled 309,771 which was a 53 percent increase over FY2008 submissions (202,619). During the new influx of submissions Grants.gov was also in the midst of completing the transition from PureEdge to Adobe forms. The transition was completed on March 3, 2009 and took a great deal of effort and coordination between the Grants.gov PMO and grantor agencies.

System Growth and Accomplishments

September 2009 ... September 30, 2009

Contact Center Call Volume Increase: The Contact Center is the Grants.gov help desk for the applicant community. The Contact Center handled a total of 285,042 customer inquiries, a 34 percent increase over FY2008.

---> September 30, 2009

Grants.gov Community Outreach: Throughout the year Grants.gov attends and hosts sessions directly relating to the find and apply process for federal grants. In FY2009 Grants.gov held 72 interactive presentations for the grant community with 6,930 participants, these included eight congressional grant workshops.

---> September 30, 2009

Technical Augmentation Design (Boost) Begins: Once complete, the "Boost" will facilitate and increase the processing capacity of the Grants.gov system. It will increase the accessibility and reliability of Grants.gov for applicants and grant-making agencies.

---> September 18, 2009

Grants.gov Surpassed 300,000 Submissions for FY2009: Submissions grew by 53 percent over FY2008 (202,619). The growth was attributed to the Recovery Act, which resulted in an overall increase of Web site traffic and application submissions.

Over 200,000 Submissions Received: Processed a total of 205,591 applications, surpassing the 202,619 applications processed in FY2008 with more than four months remaining in FY2009.

March 2009 ... March 31 2009

National Grants Partnership Summit: A General Accounting Officer (GAO) auditor was present to speak on behalf of Grants.gov and the system capacity in regards to the Recovery Act, at which time Grants.gov anticipated a 60 percent increase in Web site traffic and application submissions as a result of Recovery Act.

---> March 27, 2009

Congressman John Tierney Grants Seminar: Grants.gov presented information on finding and applying for grants as well as updates and enhancements to the system, to include the update to the organization registration process. There were a total of 110 attendees.

Adobe Reader 8.1.4 Confirmed Compatible with Grants.gov

---> March 13, 2009

Adobe Reader 9.1 is Confirmed Compatible with Grants.gov

---> March 5, 2009

Highest Contact Center Call Volume Reached: Grants.gov expanded phone line capacity for the Contact Center due to extraordinarily high call volume. Beginning in February the Contact Center was inundated with inquiries related to finding Recovery Act opportunities. In March, call volume peaked at a record high of 36,287 calls.

---- March 3, 2009

Transition to Adobe System Successfully Completed: Through the combined efforts of Grants.gov and the 26 federal grant-making agencies, the transition to Adobe was successfully completed. This was a major effort which required the coordination of resources and extensive planning to migrate all funding opportunities from the PureEdge System to the Adobe System.

Recovery Act Opportunities Posted: Agencies began posting grant opportunities on Grants.gov under the specific "Recovery Act" category. The new category allowed applicants to focus their search for opportunities created as a part of the \$787 billion Recovery Act stimulus package.

Federal Demonstration Partnership (FDP) Meeting: Grants.gov presented program activities and status including the transition to Adobe and the proposed system architecture within a "cloud computing" environment to an audience of 125 members. The audience consisted of university scholars, federal agency representatives, and members of the general public. Grants.gov provides regular updates to the FDP.

ATo7 Testing Environment System Update: Grants.gov testing environment (AT07) was upgraded. Upgrades were made to the system software including: Weblogic 10.0, Adobe lifecycle 8.2 update 1, and Java 1.5 Environment. These upgrades maximized the testing environment performance.
