Purpose of Modification:

- Down-Posting of Cleared Facilities as clearance can be demonstrated;
- Communication of Survey Results;
 - Generalized Employee Communications;
 - Facility-specific Employee Communications;
 - Interim and Final Status Reports posted on Be Website;
- Preparation of Phase III Cost Estimate for remediating identified areas (facilities) of concern.

All other Terms and Conditions remain unchanged.
