### **UPDATE: NRC NAMES PANELISTS FOR PUBLIC MEETING TO DISCUSS SAN ONOFRE NUCLEAR GENERATING STATION ISSUES**

Representatives from the California Public Energy Commission, the California Public Utilities Commission and local community organizations and residents have agreed to participate in a panel discussion Oct. 9 on issues related to the San Onofre Nuclear Generating Station.

The two-part meeting will be held between 6 and 9:30 p.m. at the St. Regis Monarch Beach Hotel, One Monarch Beach Resort, in Dana Point, Calif.

The first part of the meeting will be a facilitated roundtable discussion on topics of significant public interest with observation by members of the public.
