¹STATE: The state abbreviation for the challenged jurisdiction.

²JURISDICTION: The name of the challenging jurisdiction/Governmental Unit (GU).

³HEO: The name of the Highest Elected Official of the GU that submitted the challenge.

⁴STATUS: The result of CQR challenge research. Statuses are "Pending", "Change" or "No Change". A "Pending" status is present for a challenge from the date the challenge is received in the CQR Office until after the GU, and any affected GU, receives their final results letter. At that time, the "Pending" status will be updated to "Change" or "No Change", as appropriate. A "Change" indicates the Census Bureau has (a) completed its research, (b) determined the corrected count, (c) notified the local official(s) affected by this change, but (d) not yet prepared and posted the errata counts on the Census Bureau's website. A "No Change" means that, based on CQR research, no change was made to a jurisdiction's counts. When no change to the counts is made, a "Pending" status is updated to "No Change" after the challenging GU receives their final results letter.
