## Voting Information

In order to register to vote, you must be a United States citizen, a resident of Washington State, and at least 18 years of age.

### **Register to vote or change your address:**

You can register by filling out a voter registration card at any county auditor's or elections office or online at the Washington Secretary of State's website. If you have moved within the same county, you must change your address with your county auditor's or elections office. If you have moved to a different county, your address change must be submitted through the Secretary of State's office.

### **Military and Overseas Absentee Ballots:**

Absentee ballots are available for registered voters who are overseas and for military personnel who are registered to vote but do not believe they will receive their ballot in time to vote. Further information is available on the Secretary of State's website.
