## Quick Glance of 2005 SLGS Regulation Changes

Subject Area	New Rule (in brief)	Old Rule (in brief)
Subscriptions	<p><i>No cancellations are permitted</i></p> <p><i>No changes to issue dates are permitted</i></p> <p><i>Dollar amounts of subscriptions can be changed up to 10 (ten) percent</i></p>	<p>Cancellations were permitted up to a specified window of time</p> <p>Issue date could be postponed up to 7 (seven) days beyond original issue date</p> <p>Dollar amounts of subscriptions could be changed by up to 10 (ten) percent or \$10,000,000, whichever was greater</p>
Early Redemptions	<p><i>14 (fourteen) day advance notification is required</i></p> <p><i>Early redemption requests can only be made on securities that have been issued</i></p>	<p>10 (ten) day advance notification was required</p> <p>Early redemption requests could be made on securities any time after subscription</p>
Yields	<p><i>Yield pickups on early redemptions are prohibited; yield is calculated based on the IRS definition of yield (Section 148 of the Internal Revenue Code)</i></p>	<p>No old rule</p>
Cost of SLGS	<p><i>SLGS rate fee is approximately 1(one) basis point</i></p>	<p>SLGS rate fee was 5 (five) basis points</p>
SLGSafe	<p><i>Use of SLGSafe is mandatory for all SLGS transaction activity</i></p>	<p>SLGSafe was not mandatory</p>
Certifications	<p><i>Agent certifications and yield certifications are required</i></p>	<p>No specific certifications were required</p>
Rate Table	<p><i>Daily SLGS rate table is produced and published by 10:00 AM Eastern Time on the effective date of the rates</i></p>	<p>Daily SLGS rate table was produced using the prior day's closing prices</p>
Trading Hours	<p><i>SLGSafe open trading hours are 10:00 AM to 10:00 PM Eastern Time. SLGSafe inquiry functions are available from 8:00 AM to 10:00 PM Eastern Time</i></p>	<p>SLGSafe open trading hours were 8:00 AM to 10:00 PM Eastern Time</p>

### SLGS Terms Defined

<b>SLGS</b>	<i>State and Local Government Series Securities</i>
<b>SLGSafe</b>	<i>A secure internet site through which subscribers submit SLGS securities transactions</i>
<b>Subscription</b>	<i>A request to purchase SLGS securities that locks in the current day's rate table</i>
<b>Time Deposit Securities</b>	<i>Book entry securities issued in whole dollar amounts with a minimum amount of \$1000. Interest is paid semi-annually on securities with maturities beyond 1 year</i>
<b>Demand Deposit Securities</b>	<i>One-day certificates issued in a minimum amount \$1000. Interest is accrued and applied to the principal daily.</i>
