**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

*N*-Butyl-*N*-ethyl- $\alpha,\alpha,\alpha$ -trifluoro-2,6-dinitro-*p*-toluidine (CAS No. 1861-40-1) (provided for in subheading 2921.43.90).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used as a pre-emergence herbicide that controls annual grasses and broadleaf weeds in alfalfa, lettuce, peanuts, tobacco, and established turf. The subject product is imported from Italy.

There is a typo in the chemical name given in Section 1(a) of the bill. Instead of “...-z,6-dinitro-...”, it should read -2,6-dinitro-...”. The existing heading 9902.29.59, which would be extended by this bill, has the correct article description.

## A BILL

To extend the temporary suspension of duty on Benfluralin.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. BENFLURALIN.**

4       (a) **IN GENERAL.**—Heading 9902.29.59 of the Har-  
5       monized Tariff Schedule of the United States (relating to  
6       *N-Butyl-N-ethyl- $\alpha,\alpha,\alpha$ -trifluoro-*z*,6-dinitro-*p*-toluidine*) is  
7       amended by striking “12/31/2009” and inserting “12/31/  
8       2011”.

9       (b) **EFFECTIVE DATE.**—The amendment made by  
10       subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
