N-Ethyl-N-(2-methyl-2-propenyl)-2,6-dinitro-4-(trifluoromethyl)benzenamine (Ethalfluralin) (CAS No. 55283-68-6) (provided for in subheading 2921.43.22).

Product information, including uses/applications and source(s) of imports:

The subject chemical is a synthetic organic chemical that is used as the technical active ingredient for a selective preemergence herbicide, which is used to control weeds as a preplant for soybeans, dry beans, peanuts, and other crops. Dow AgroSciences imports the subject chemical from Italy.

A BILL

To extend the temporary suspension of duty on Ethalfluralin.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ETHALFLURALIN.**

4 (a) IN GENERAL.—Heading 9902.30.49 of the Har-
5 monized Tariff Schedule of the United States is amended
6 by striking “12/31/2009” and inserting “12/31/2011”.

7 (b) EFFECTIVE DATE.—The amendment made by
8 subsection (a) applies with respect to goods entered, or
9 withdrawn from warehouse for consumption, on or after
10 the 15th day after the date of the enactment of this Act.
