**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 110th Congress¹**

[Date approved: April 10, 2008]²

Bill No. and sponsor: H. R. 4500 (Mr. Walter William Herger, Jr. of California).

Proponent name,³ location: Wal-Mart Stores, Inc., Bentonville, AR.

Other bills on product (110th Congress only): None.

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Direction finding compasses, the foregoing other than optical instruments, gyroscopic compasses or electrical compasses (provided for in subheading 9014.10.90).

Check one: Same as that in bill as introduced.
 Different from that in bill as introduced (see Technical comments section).

Product information, including uses/applications and source(s) of imports:

This bill covers all types of non-electrical, non-gyroscopic compasses used for navigational purposes. Compasses generally are stand-alone instruments containing a magnetized pointer or dial encased in a fluid-filled capsule to indicate the direction of magnetic north. These compasses are used in recreational, orienteering, automotive after-market, marine, and to a lesser extent aviation applications. Many compasses for use in vehicles are mounted on a base plate containing such features as adjustable declination, map scales, magnifying lens, rotating bezel, sight, and mirror to assist in reading maps coordinates and taking bearings. Other compasses are designed for use as an aftermarket accessory or compass component in other products.

Two companies report they manufacture these compasses in the United States.⁴ The majority of compass imports are sourced from China, France, Finland, and Sweden.

3 **SECTION 1. CERTAIN COMPASSES.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new heading:
