The subject product is a synthetic organic chemical that is used as an intermediate in the production of organic pigments. It is imported from China, Germany, India, and Switzerland.

3 **SECTION 1. ACETOACETYL-2,5-DIMETHOXY-4-CHLORO-**
4 **ANILIDE.**

5 (a) **IN GENERAL.**—Heading 9902.23.64 of the Har-
6 monized Tariff Schedule of the United States is amended
7 by striking “12/31/2009” and inserting “12/31/2011”.

8 (b) **EFFECTIVE DATE.**—The amendment made by
9 subsection (a) applies with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of the enactment of this Act.
