**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Mixtures of N,N-dimethyl-2[3-(4,6-dimethoxypyrimidin-2-yl)ureidosulfonyl]-4-formylaminobenzamide (Foramsulfuron) (CAS No. 173159-57-4), methyl 4-iodo-2-[3-(4-methoxy-6-methyl-1,3,5-triazin-2-yl)ureidosulfonyl]benzoate, sodium salt (Iodosulfuronmethyl-sodium) (CAS No. 144550-36-7) and application adjuvants (provided for in subheading 3808.93.15).

The subject product is a postemergence corn herbicide that is used for grass and broadleaf control. The product is imported from Germany.

## A BILL

To extend the temporary suspension of duty on product mixtures containing Foramsulfuron and Iodosulfuronmethyl-sodium.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PRODUCT MIXTURES CONTAINING**  
4 **FORAMSULFURON AND**  
5 **IODOSULFURONMETHYL-SODIUM.**

6 (a) IN GENERAL.—Heading 9902.11.49 of the Har-  
7 monized Tariff Schedule of the United States is amended  
8 by striking “12/31/2009” and inserting “12/31/2011”.

9 (b) EFFECTIVE DATE.—The amendment made by  
10 subsection (a) applies with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of the enactment of this Act.
