**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 110th Congress¹**

Bill No. and sponsor: H.R. 4634 (Mr. Sam Graves of Missouri).

Proponent name,³ location: Bayer CropScience, Research Triangle Park, NC.

Other bills on product (110th Congress only): H.R. 5476 (Mr. Brad Miller of North Carolina).

Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mixtures of 2-ethoxy-2,3-dihydro-3,3-dimethyl-5-benzofuranylmethanesulfonate (Ethofumesate) (CAS No. 26225-79-6) and application adjuvants (provided for in subheading 3808.93.15).

Product information, including uses/applications and source(s) of imports:

The subject product is a selective herbicide for use in established and newly planted tall fescue and perennial ryegrass that is grown for sod in western portions of the United States. The product, either alone or in combination with other herbicides, also provides broad-spectrum weed control by protecting a sugarbeet crop through the germination, emergence, and early seedling growth stages. It is imported from Germany.

However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

6 (a) IN GENERAL.—Subchapter II of chapter 99 of
7 the Harmonized Tariff Schedule of the United States is
