**Nature of bill:** Temporary duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

N,N,N',N'-Tetrakis(2-hydroxyethyl)-hexanediamide (CAS No. 6334-25-4) (provided for in subheading 2924.19.80).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used to make polyester powder coatings. Powder coatings are solids that are applied as powders by electrostatic means in a manner that avoids the use of volatile organic solvents. Volatile organic solvents are an environmental contaminant regulated in most States. Direct electrostatic application of powders also reduces material waste and air pollution caused by "blow-by" of liquid sprays. High-temperature curing of the applied coating provides good weather-resistance. The product is imported from Switzerland.

The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
