The subject product is a synthetic organic chemical that is used to increase the performance, especially weather-fastness, of coatings used in outdoor environments. It is imported from Germany.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 1-ACETYL-4- (3-DODECYL-2, 5-DIOXO-1-**  
4 **PYRROLIDINYL)-2,2,6,6-**  
5 **TETRAMETHYLPIPERIDINE.**

6 (a) IN GENERAL.—Heading 9902.04.06 of the Har-  
7 monized Tariff Schedule of the United States (relating to  
8 1-Acetyl-4- (3-dodecyl-2, 5-dioxo-1-pyrrolidinyl)-2,2,6,6-  
9 tetramethylpiperidine) is amended by striking the date in  
10 the effective period column and inserting “12/31/2011”.

1       (b) EFFECTIVE DATE.—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
