**Bill No. and sponsor:** H.R. 4795 (Mr. Howard Coble of North Carolina).

**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Mixtures of 1H-1,2,4-triazole, 1-((2-chlorophenoxy)phenyl)-4-methyl-1,3-dioxolan-2-yl)methyl-(Difenoconazole) (CAS No. 119446-68-3), (R,S)-2-((2,6-dimethylphenyl)methoxyacetyl amino)propionic acid, methyl ester (Mefenoxam) (CAS Nos. 70630-17-0, and 69516-34-3) and application adjuvants (provided for in subheading 3808.92.15).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a mixture of synthetic organic fungicides that are used as seed treatment to prevent the development of fungal disease on crops when the plant is most vulnerable. It is imported from Canada.<sup>4</sup>

## A BILL

To extend the suspension of duty on mixtures of difenoconazole and mefenoxam.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MIXTURES OF DIFENOCONAZOLE AND**  
4 **MEFENOXAM.**

5 (a) IN GENERAL.—Heading 9902.12.53 of the Har-  
6 monized Tariff Schedule of the United States (relating to  
7 mixtures of difenoconazole and mefenoxam) is amended  
8 by striking “12/31/2009” and by inserting “12/31/2011”.

9 (b) EFFECTIVE DATE.—The amendment made by  
10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
