Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mixtures of cyhalothrin (cyclopropanecarboxylic acid, -(2-chloro-3,3,3-trifluoro-1-propenyl)-2,2-dimethyl-, cyano(3-phenoxyphenyl)methyl ester, [1 α (S*), 3 α (Z)]-(\pm)-) (CAS No. 91465-08-6) and application adjuvants (provided for in subheading 3808.91.25).

Product information, including uses/applications and source(s) of imports:

The subject product is a mixture of synthetic organic chemical components, which contains the active ingredient lambda-cyhalothrin and is used in the manufacture of insecticides in the class of chemistry known as synthetic pyrethroids. Synthetic pyrethroids are synthesized compounds based on the chemical structure and biological activity of pyrethrins, components of the natural extract pyrethrum which is produced from the chrysanthemum plant. The products are formulated specifically for use in structural pest control, turf, and landscaping. The proponent imports this product from the United Kingdom.

A BILL

To extend the suspension of duty on mixtures of cyhalothrin and application adjuvants.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MIXTURES OF CYHALOTHRIN AND APPLICA-**
4 **TION ADJUVANTS.**

5 (a) IN GENERAL.—Heading 9902.02.09 of the Har-
6 monized Tariff Schedule of the United States (relating to
7 mixtures of cyhalothrin and application adjuvants) is
8 amended by striking “12/31/2009” and by inserting “12/
9 31/2011”.

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) applies to goods entered, or withdrawn from
3 warehouse for consumption, on or after the 15th day after
4 the date of the enactment of this Act.
