(Methidathion) (CAS No. 950-37-8) (provided for in subheading 2934.99.90).

The subject product is a synthetic organic chemical that is formulated into agricultural insecticides for use on citrus and fruit crops. The product is imported from Switzerland.

The Commission staff suggests that the article description of HTS heading 9902.02.02 be modified as shown on page 1 of this report to include the common name in parentheses after the chemical name.

## A BILL

3 **SECTION 1. S-[(5-METHOXY-2-OXO-1,3,4-THIADIAZOL-3(2H)-**  
4 **YL)METHYL]-O,O-DIMETHYL**  
5 **PHOSPHORODITHIOATE.**

6 (a) IN GENERAL.—Heading 9902.02.02 of the Har-  
7 monized Tariff Schedule of the United States (relating to  
8 S-[(5-Methoxy-2-oxo-1,3,4-thiadiazol-3(2H)-yl)methyl]-  
9 O,O-dimethyl phosphorodithioate is amended by striking  
10 “12/31/2009” and by inserting “12/31/2011”.

1       (b) EFFECTIVE DATE.—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
