**Nature of bill:** Extension with modification of temporary duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

$\alpha$ -2-Dichloro-5-[4-(difluoromethyl)-4,5-dihydro-3-methyl-5-oxo-1H-1,2,4-triazol-1-yl]-4-fluorobenzenepropanoic acid, ethyl ester (Carfentrazone ethyl) (CAS No. 128639-02-1) and formulations thereof (provided for in subheadings 2933.99.22 and 3808.93.15).

**Product information, including uses/applications and source(s) of imports:**

The subject products are an organic chemical and formulations of that chemical, which are used to eradicate weeds on corn, cotton, soybean, and wheat crops. The subject products are imported from China.

The Commission staff suggests that the article description on page 1 of this report be used to modify the current article description in HTS heading 9902.01.54 in order to correct the spelling of the common industry chemical name.

<sup>4</sup> The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

## A BILL

To extend and modify the temporary suspension of duty  
on Carfentrazone.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CARFENTRAZONE.**

4 (a) IN GENERAL.—Heading 9902.01.54 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6 Carfentrazone) is amended—

7 (1) by striking “(provided for in subheading  
8 2933.99.22)” and inserting “(provided for in sub-  
9 heading 2933.99.22) and any formulations con-  
10 taining such compound (provided for in subheading  
11 3808.93.15)”; and

1           (2) in the effective period column, by striking  
2           the date contained therein and inserting “12/31/  
3           2011”.

4           (b) EFFECTIVE DATE.—The amendments made by  
5           subsection (a) apply to goods entered, or withdrawn from  
6           warehouse for consumption, on or after the 15th day after  
7           the date of the enactment of this Act.
