Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Fluorobenzene (CAS No. 462-06-6) (provided for in subheading 2903.69.80).

Product information, including uses/applications and source(s) of imports:

The subject product, a synthetic organic chemical, is used to produce an agricultural intermediate, which is further processed into an insecticide. It is imported from China and India.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FLUOROBENZENE.**

4 (a) IN GENERAL.—Heading 9902.03.05 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 Fluorobenzene) is amended by striking the date in the ef-
7 fective period column and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
