**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

7,7'-[1,3-Propanediylbis[imino(6-fluoro-1,3,5-triazine-4,2-diyl)imino[2-[(aminocarbonyl)amino]-4,1-phenylene]azo]]bis-, sodium salt (CAS No. 143683-24-3) (provided for in subheading 3204.16.30).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic reactive dye, or a preparation based thereon. Reactive dyes are particularly appropriate for dyeing cellulosic fibers, including cotton, viscose, and linen. They are also appropriate for dyeing wool. The subject product is imported from Switzerland.

7 (a) IN GENERAL.—Heading 9902.02.46 of the Har-  
8 monized Tariff Schedule of the United States (relating to

2 diyl)imino[2-[(aminocarbonyl)amino]-4,1-phen-  
3 ylene]azo]]bis-, sodium salt) is amended by striking “12/  
4 31/2009” and inserting “12/31/2011”.

5 (b) EFFECTIVE DATE.—The amendment made by  
6 subsection (a) applies to goods entered, or withdrawn from  
7 warehouse for consumption, on or after the 15th day after  
8 the date of the enactment of this Act.
