Chloroacetic acid, sodium salt (CAS No. 3926-62-3) (provided for in subheading 2915.40.50).

The subject product is a synthetic organic salt that is used as an intermediate in the production of betaines and carboxymethylcellulose, both of which are ingredients in cosmetics. The product is imported from Germany.

## A BILL

To extend the temporary suspension of duty on Chloroacetic acid, sodium salt.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CHLOROACETIC ACID, SODIUM SALT.**

4 (a) IN GENERAL.—Heading 9902.12.34 of the Har-  
5 monized Tariff Schedule of the United States (relating to  
6 Chloroacetic acid, sodium salt) is amended by striking  
7 “12/31/2009” and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by  
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
