Nature of bill: Extension of temporary duty suspension through December 31, 2011.

for in subheading 3204.19.20).

Product information, including uses/applications and source(s) of imports:

The subject product is a synthetic organic chemical that is used as an infrared absorbing dye. The product improves the response of photosensitive formulations in digital computer-to-photographic plate systems. The product is imported from Germany and Japan.

Technical comments:⁴

The Commission staff notes that the subject product is classified in HTS subheading 3204.19.20, as indicated on page 1 of this report. The subheading reference in the article description of HTS heading 9902.23.13 is incorrect. The Commission staff suggests that the article description of heading 9902.23.13 be amended by deleting "2934.99.90" and inserting "3204.19.20" in lieu thereof.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AN INFRARED ABSORBING DYE.**

4 (a) IN GENERAL.—Heading 9902.23.13 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 an infrared absorbing dye) is amended by striking the date
7 in the effective period column and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
