**Nature of bill:** Extension of duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Mixtures of methyl 4-iodo-2-[3-(4-methoxy-6-methyl-1,3,5-triazin-2-yl)ureidosulfonyl]benzoate, sodium salt (Iodosulfuron methyl, sodium salt) (CAS No. 144550-36-7) and application adjuvants (provided for in subheading 3808.93.15).

**Product information, including uses/applications and source(s) of imports:**

The subject product is an organic herbicide that is applied to the soil in the fall to control winter and early spring annual weeds, particularly in corn and soybean rotations. The product is imported from Germany.

1 **SECTION 1. MIXTURES OF METHYL 4-iodo-2-[3-(4-METHOXY-**  
2 **6-METHYL-1,3,5-TRIAZIN-2-**  
3 **YL)UREIDOSULFONYL] BENZOATE, SODIUM**  
4 **SALT (IODOSULFURON METHYL, SODIUM**  
5 **SALT) AND APPLICATION ADJUVANTS.**

6 (a) IN GENERAL.—Heading 9902.11.44 of the Har-  
7 monized Tariff Schedule of the United States (relating to  
8 mixtures of methyl 4-iodo-2-[3-(4-methoxy-6-methyl-1,3,5-  
9 triazin-2-yl)ureidosulfonyl] benzoate, sodium salt (Iodosul-  
10 furon methyl, sodium salt) and application adjuvants) is  
11 amended by striking “12/31/2009” and inserting “12/31/  
12 2011”.

13 (b) EFFECTIVE DATE.—The amendment made by  
14 subsection (a) applies to goods entered, or withdrawn from  
15 warehouse for consumption, on or after the 15th day after  
16 the date of the enactment of this Act.
