Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

(1,3,4,5,6,7-Hexahydro-1,3-dioxo-2H-isoindol-2-yl)methyl 2,2-dimethyl-3-(2-methylprop-1-enyl)cyclopropane carboxylate (CAS No. 7696-12-0) (Tetramethrin) (provided for in subheading 2925.19.91).

Product information, including uses/applications and source(s) of imports:

The subject product, commonly known as Tetramethrin, is a synthetic organic chemical that is the active ingredient in Valent's Neo-Pynamin® insecticide. It is effective on flying and crawling insects including mosquitoes, flies, and cockroaches. The product is imported from Japan.

To extend the temporary suspension of duty on
Tetramethrin.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TETRAMETHRIN.**

4 (a) IN GENERAL.—Heading 9902.24.34 of the Har-
5 monized Tariff Schedule of the United States is amended
6 by striking “12/31/2009” and inserting “12/31/2011”.

7 (b) EFFECTIVE DATE.—The amendment made by
8 subsection (a) applies with respect to goods entered, or
9 withdrawn from warehouse for consumption, on or after
10 the 15th day after the date of the enactment of this Act.
