**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

[5-(Phenylmethyl)-3-furanyl]methyl 2,2-dimethyl-3-(2-methyl-1-propenyl)cyclopropanecarboxylate (Resmethrin) (CAS No. 10453-86-8) (provided for in subheading 2932.19.10).

**Product information, including uses/applications and source(s) of imports:**

The subject product, commonly known as Resmethrin, is a synthetic organic chemical that is used as an insecticide. It is used on pests such as flies, mosquitoes, and cockroaches in both household and industrial settings. The product is imported from Japan and Hungary.

## A BILL

To extend the temporary suspension of duty on Resmethrin.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. RESMETHRIN.**

4       (a) IN GENERAL.—Heading 9902.10.83 of the Har-  
5       monized Tariff Schedule of the United States is amended  
6       by striking “12/31/2009” and inserting “12/31/2011”.

7       (b) EFFECTIVE DATE.—The amendment made by  
8       subsection (a) applies with respect to goods entered, or  
9       withdrawn from warehouse for consumption, on or after  
10      the 15th day after the date of the enactment of this Act.
