**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

Pentaerythritol tris (3-(1-aziridinyl) propionate (CAS No. 57116-45-7) (provided for in subheading 2933.99.97).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical that is used as a crosslinker in the finishing and adhesive industries. It improves the final properties of the materials used in many adhesive, coating, and printing applications. The product is imported from Japan.

The Commission staff notes that the current chemical description is vague and suggests that the article description on page 1 of this report be used in HTS heading 9902.11.88 in order to provide a more specific chemical name.

<sup>4</sup> The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

## A BILL

To extend the suspension of duty on Polyfunctional aziridine.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. POLYFUNCTIONAL AZIRIDINE.**

4       (a) IN GENERAL.—Heading 9902.11.88 of the Har-  
5       monized Tariff Schedule of the United States (relating to  
6       Polyfunctional aziridine) is amended by striking “12/31/  
7       2009” and inserting “12/31/2011”.

8       (b) EFFECTIVE DATE.—The amendment made by  
9       subsection (a) applies to goods entered, or withdrawn from  
10      warehouse for consumption, on or after the 15th day after  
11      the date of the enactment of this Act.
