The subject product is the active ingredient in SCALA<sup>TM</sup> SC, which protects tree nuts, fruits, vegetables, and potato crops from diseases such as Botrytis and Monilinia. The product is imported from Germany.

## A BILL

To extend the temporary suspension of duty on Pyrimethanil.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. PYRIMETHANIL.**

4       (a) IN GENERAL.—Heading 9902.10.36 of the Har-  
5       monized Tariff Schedule of the United States (relating to  
6       Pyrimethanil) is amended by striking “12/31/2009” and  
7       inserting “12/31/2011”.

8       (b) EFFECTIVE DATE.—The amendment made by  
9       subsection (a) applies to goods entered, or withdrawn from  
10      warehouse for consumption, on or after the 15th day after  
11      the date of the enactment of this Act.
