1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. VINCLOZOLIN.**

4 (a) **IN GENERAL.**—Heading 9902.01.19 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 3-(3,5-Dichlorophenyl)-5-ethenyl-5-methyl-2,4-
7 oxazolidineidione) is amended by striking the date in the
8 effective period column and inserting “12/31/2011”.

9 (b) **EFFECTIVE DATE.**—The amendment made by
10 subsection (a) applies with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of the enactment of this Act.
