**Nature of bill:** Extension of temporary duty suspension through December 31, 2011.

2-Methyl-4-chlorophenoxy-acetic acid, dimethylamine salt (MCPA dimethylammonium) (CAS No. 2039-46-5) (provided for in subheading 2921.11.00).

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical herbicide that is used to control a wide variety of broad-leaved weeds in cereals, grasses, flax, and non-crop areas. The product is imported from the Netherlands and the United Kingdom.

The Commission staff recommends that the article description of HTS heading 9902.25.42 be modified as shown on page 1 of this report to include the common chemical abbreviation in parentheses.

## A BILL

To extend the temporary suspension of duty on 2-Methyl-4-chlorophenoxy-acetic acid, dimethylamine salt.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 2-METHYL-4-CHLOROPHENOXY-ACETIC ACID,**  
4 **DIMETHYLAMINE SALT.**

5 (a) IN GENERAL.—Heading 9902.25.42 of the Har-  
6 monized Tariff Schedule of the United States (relating to  
7 2-Methyl-4-chlorophenoxy-acetic acid, dimethylamine salt)  
8 is amended by striking the date in the effective period col-  
9 umn and inserting “12/31/2011”.

1       (b) EFFECTIVE DATE.—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
