**MEMORANDUM ON PROPOSED TARIFF LEGISLATION
of the 110th Congress¹**

[Date approved: August 8, 2008]²

Bill No. and sponsor: H.R. 5358 (Mr. Gary L. Ackerman of New York).

Proponent name,³ location: Leviton Manufacturing Co., Inc., Little Neck, NY.

Other bills on product (110th Congress only): None.

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

RCA jacks (phono connectors) and banana jack connectors (provided for in subheading 8536.69.80).

Check one: Same as that in bill as introduced.
 Different from that in bill as introduced (see Technical comments section).

Product information, including uses/applications and source(s) of imports:

RCA connectors are a type of electrical connector commonly used in the audio/visual market. "RCA" derives from the Radio Corporation of America, which introduced this connector design in the 1940s for monaural phonographs. Such connectors have been adapted over time and are now used with audio, VCR, and DVD equipment, as well as computers and gaming consoles. A separate wire must be used for each type of signal being transmitted through the connector.

Banana connectors are another type of electrical connector used in conjunction with amplifier-to-speaker connections. They feature a single wire to conduct the signal and have screw-on rear-side connections. Standard banana plugs are used with front-side connections. The metal pin in the connector is held in place by curved springs—giving rise to the name of the connector. Binding post adapters feature an optional front-side connection, either screw-on or push-in for banana plugs, within audio speaker connections. A protective housing prevents the user from contacting the electrical charge.

The principal U.S. import source of this product is China. Dutiable U.S. imports under HTS subheading 8536.69.80 (a broader category than is covered by this bill) totaled \$336.5 million in 2007, of which China accounted for \$125.7 million. Other import sources included Germany, Japan, and Taiwan.

Technical comments:⁴

The proponent has suggested changing the product description in the bill as drafted to replace the phrase “voice and data and audio connectors and adaptors” with the references to RCA and banana jack connectors. Although the proponent indicated that the intended scope would be residential and commercial grade products, the HTS does not contain definitions for those grades. Unless the terms can be defined in a legal note, the reference to product grades should be eliminated from the article description. The proponent is working with the office of Senator Charles E. Schumer to produce a Senate version of this bill that will incorporate a revised, narrower article description, but the revised language is not yet available. The amended description shown on page 1 does reflect the intended narrowing of the scope of the bill.

⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
