**MEMORANDUM ON PROPOSED TARIFF LEGISLATION  
of the 110<sup>th</sup> Congress<sup>1</sup>**

**Bill No. and sponsor:** H.R. 5431 (Mr. Keith Ellison of Minnesota).

**Proponent name,<sup>3</sup> location:** Entegris, Inc., Chaska, Minnesota.

**Other bills on product (110<sup>th</sup> Congress only):** None.

**Nature of bill:** Temporary duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Cellular plastic membrane sheets of polytetrafluoroethylene resin measuring 10 microns to 140 microns thick that, when tested, retain polystyrene latex beads of 0.15 microns diameter, and cellular plastic membrane sheets of polysulfone resin of various thicknesses and porosity, each certified by the importer for use in manufacturing filters of heading 8421 (provided for in subheading 3921.19.00).

**Product information, including uses/applications and source(s) of imports:**

The subject products are designed to be used as multipurpose ultra-purification filters in various downstream semiconductor device manufacturing applications. The polytetrafluoroethylene (Teflon) membrane filters are highly chemically resistant to the passage of various corrosive liquid materials, while the polysulfone membranes have a lower chemical resistance but allow for a higher rate of liquid passage. The products are imported from Japan.

The Commission staff recommends that the article description on page 1 of this report be used in the proposed new heading in order to more accurately describe the product, and to provide the correct name of the resin.<sup>5</sup>

## A BILL

To suspend temporarily the duty on certain cellular plastic  
sheets for use in filters.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. CELLULAR PLASTIC SHEETS FOR FILTERS.**

4       (a) IN GENERAL.—Subchapter II of chapter 99 of  
5       the Harmonized Tariff Schedule of the United States is  
6       amended by inserting in numerical sequence the following  
7       new heading:

“	9902.01.00	Cellular Plastic Sheets; of poly-tetrafluoroethylene measuring 10 microns to 140 microns thick with pore size less than 0.15 microns which retain Polystyrene Latex beads of 0.15 microns or less, or of polyethersulfone, for use in manufacturing filters of heading 8421 (provided for in subheading 3921.19.00) .....
