Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Polymer of propanoic acid, 3-hydroxy-2-(hydroxymethyl)-2-methyl-polymer with 2,2-bis(hydroxymethyl)-1,3-propanediol and oxirane, decanoate octanoate (CAS No. 326794-49-4) (provided for in subheading 3907.99.00).

Product information, including uses/applications and source(s) of imports:

The product subject to this bill is a dendritic polyester, a highly branched polyester polymer. This patented polymer is used to make acrylates, which, in turn, are used to make certain inks and coatings that are cured by ultraviolet light; it is also used as a component in polyurethane foams. This product is sold under the trade name Boltorn® H311, a viscous liquid at room temperature containing 10% water. The product is imported from proponent's plants in Germany and Sweden.
