Technical comments:³

The Commission notes that the bill, as introduced, would amend and extend an existing duty suspension that is provided under HTS heading 9902.05.02. The Commission suggests that, in lieu of amending and extending HTS heading 9902.05.02, a new duty suspension be enacted using the article description on page 1 of this report because the proponent has indicated that the product for which a duty suspension is being sought is not covered by HTS heading 9902.05.02, nor is it described by the amended article description in the bill. The article description on page 1 contains the correct chemical name, CAS number and HTS classification.

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
