#### Product information, including uses/applications and source(s) of imports:

Aircraft exterior emergency lights provide illumination of the airplane's overwing egress pathways and the ground contact area of the base of each slide during an emergency evacuation. The principal import source of these aircraft exterior emergency lights is Canada.

#### **Technical comments:**<sup>3</sup>

It is suggested that the article description on page 1 of this report be used in the proposed new heading to provide the correct HTS subheading reference (9405.60.40) and to indicate clearly that the goods are for aircraft use.

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

- 8 (b) Effective Date.—The amendment made by
