1,1,2-2-Tetrafluoroethene, oxidized, polymerized (CAS No. 69991-61-3) (provided for in subheading 3907.20.00).

#### Product information, including uses/applications and source(s) of imports:

The subject products are functional perfluoropolyethers (PFPE) that are synthesized from a proprietary process which is based on the photo oxidation of tetrafluoroethylene monomer. The products are generally clear, colorless to light yellow fluids, having a range of viscosities and molecular weights. They exhibit excellent viscosity index, low evaporative loss properties and good thermal stability. These products are used for polymer modifications and polymerizations, and PFPE lubricants for electronic components, and various surface treatment applications. The subject products are imported from Italy.
