Nature of bill: Temporary duty suspension through December 31, 2009.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Oxiranemethanol, polymers with reduced methyl esters of reduced polymerized oxidized tetrafluoroethylene (CAS No. 156559-18-1) (provided for in subheading 3907.20.00).

Product information, including uses/applications and source(s) of imports:

These products are functional perfluoropolyethers which are synthesized through a proprietary process of photo oxidation of tetrafluoroethylene monomer. These products are described as clear, colorless, to pale yellow, medium viscosity fluids. The products are used in polymer modifications and polymerizations, and for electronic component lubrication in the magnetic disk drive industry because of their limited decomposition and thermal stability. These products are imported from Italy.

A BILL

6 **ETHYLENE.**

7 (a) IN GENERAL.—Subchapter II of chapter 99 of
8 the Harmonized Tariff Schedule of the United States is

1 amended by inserting in numerical sequence the following
 2 new heading:
