**Nature of bill:** Temporary duty suspension through December 31, 2009.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Lamp-holder housings of brass, containing sockets (provided for in subheading 8536.61.00).

#### Product information, including uses/applications and source(s) of imports:

Brass lamp-holder housings containing sockets are a type of lamp-holder (bulb holder). Lamp-holders provide an electrical housing for bulb insertion in various types of lighting fixtures. Lamp-holders vary in style, range of rating, and materials for use in incandescent and fluorescent lighting devices. There are numerous configurations, including snap-in, plug-in, and screw-in, based on end-use requirements. Brass lamp-holder housings containing sockets are typically chosen for particular lighting devices for aesthetic reasons, such as in high-end household table lamps. Products made of brass can often support higher heat applications than products made of aluminum. The principal U.S. import sources of this product are China and Mexico.

#### **Technical comments:**<sup>3</sup>

It is suggested that the proposed article description be modified as shown on page 1 of this report, to be more consistent with normal tariff drafting practices.

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.
