The Commission suggests that the article description on page 1 of this report be used in the proposed new heading in order to capitalize the chemical name and to include the refrigerant number in the article description.

The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

I am writing to express Arkema Inc.'s opposition to the inclusion of S. 3305 in the omnibus Tariff Suspension & Technical Corrections Act of 2006.

Arkema is a domestic producer of 1-chloro-1,1-difluoroethane manufactured at its facility in Calvert City, Kentucky. Enactment of this legislation would negatively affect our competitive position in the US domestic market.
