**NOTICE OF COMMISSION DETERMINATION GRANTING COMPLAINANT'S  
MOTION TO TERMINATE THE INVESTIGATION IN PART**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission did not determine to review an initial determination ("ID") issued by the presiding administrative law judge ("ALJ") granting complainant's motion to terminate the above-captioned investigation as to claims 2 and 29 of United States Patent No. 6,351,398 ("the '398 patent") and claims 9, 10, 11, 13, 17, and 34 of United States Patent No. 6,538,908 ("the '908 patent"). The ID therefore became the determination of the Commission.

**SUPPLEMENTARY INFORMATION:** This investigation was instituted on June 8, 2005, based on a complaint filed by Power Integrations, Inc. ("Power Integrations") of San Jose, California. The complaint alleges violations of section 337 in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain power supply controllers and products containing the same by reason of infringement of claims

1-3, 6, 9, and 17-19 of United States Patent No. 6,212,079 (“the ‘079 patent”), claims 1-3, 5, 6, 24, 28, and 29 of the ‘398 patent, claims 8 and 12 of United States Patent No. 6,366,481 (“the ‘481 patent”), and claims 1, 4, 9-11, 13, 17, 19, 20, 22, 23, 26, 27, 30, 31, and 34 of the ‘908 patent. The Commission has previously allowed Power Integrations to terminate the investigation with regard to claims 1-3, 6, 9, and 17-19 of the ‘079 patent, claims 24 and 28 of the ‘398 patent, claims 8 and 12 of the ‘481 patent, and claims 1, 4, 19, 20, 22, 23, 30, and 31 of the ‘908 patent. The complaint named a single respondent, System General Corporation.

On August 23, 2005, Power Integrations filed a Notice of Withdrawal, which the ALJ treated as a motion to terminate the investigation with regard to claims 2 and 29 of the ‘398 patent and claims 9, 10, 11, 13, 17, and 34 of the ‘908 patent.

On September 9, 2005, the ALJ issued an ID granting Power Integrations’ motion to terminate the investigation with regard to claims 2 and 29 of the ‘398 patent and claims 9, 10, 11, 13, 17, and 34 of the ‘908 patent. The ALJ found that there were no extraordinary circumstances that would prevent the partial termination of the investigation. No petitions for review of the ID were filed.

The ID became the determination of the Commission on October 12, 2005, under Commission Rule 210.42(h)(3).

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in section 210.42 of the Commission’s Rules of Practice and Procedure (19 C.F.R. § 210.42).
