**NOTICE OF COMMISSION DETERMINATION TO REVIEW AND REVERSE AN
INITIAL DETERMINATION EXTENDING THE TARGET DATE FOR COMPLETION
OF THE INVESTIGATION**

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined to review and reverse the initial determination (ID) issued on October 31, 2002, by the presiding administrative law judge (ALJ). The ID extended the target date for completion of the above-captioned investigation from December 4, 2003, to March 4, 2004. The Commission determined to review on its own motion and reverse the ID, thereby leaving December 4, 2003, as the target date for the completion of this investigation.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on October 4, 2002, based on a complaint filed on behalf of Kason Industries, Inc. of Shenandoah, Georgia. 67 *Fed. Reg.* 62264 (2002).

On October 31, 2002, the ALJ issued an ID (Order No. 5) extending the target date for completion of the investigation from December 4, 2003, to March 4, 2004. No petitions for review of the ID were filed, but the Commission determined to review the ID on its own motion pursuant to 19 C.F.R. § 210.44.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in sections 210.44, 210.45(c), and 210.51 of the Commission's Rules of Practice and Procedure (19 C.F.R. §§ 210.44, 210.45(c), and 210.51).
