Madam Speaker:

With American families and small businesses facing record high gasoline prices, Congress has adjourned to leave Washington for a five-week break. The message this sends to the American people is bad enough; its ramifications, however, are far worse. You have the power to call Congress back into session at any moment to deal with issues of urgent national importance. No one can argue that the issue of high energy costs and their impact on American families does not rise to this level. That is why we write today to request that you call Congress back into an emergency session this month and schedule a vote on the *American Energy Act* (H.R. 6566). Such an action will ensure our nation's energy crisis receives the attention – and action – it deserves.


