### Meeting Notes – National Water Quality Monitoring Council (Council) November 15-17, 2011 Salt Lake City, Utah (Agenda and list of participants on pages 4-6)

### Actions, Decisions and other Information

- 1. National Network of Reference Watersheds
  - **Decision:** Upon a motion duly made (Dave Chestnut), seconded (Curtis Cude), and carried, the Governance Document for the National Network of Reference Watersheds was approved by the Council.
  - Decision: Upon a motion duly made (Mike McDonald), seconded (Peter Tennant), and carried, the interim Executive Committee comprised of Bill Wilber (USGS), Rick Haeuber (EPA), Neil Kamman (VT DEC), and Doug McLaughlin (NCASI) was approved by the Council.
  - Action: The Council's Charge to the workgroup Prepare a workplan in the next 3 months (by Jan or Feb 2012) to be presented to Council. When completed the plan will be emailed to Council members for review.
- 2. Decision: Upon a motion duly made, seconded, and carried, the May 5, 2011 Council Meeting minutes were approved and will be posted on the website (Kim Martz).
- 3. Conference Planning Updates:
  - **Decision:** Jeff Schloss finalized a reciprocal registration agreement between Council and River Network that will make things cheaper for people who want to attend portions of both events (NMC and River Rally).
  - Local planning committee activities (Greg Pettit chair):
    - FYI: Suggested field trips include –Hood River trip including stops at Multnomah Falls and Boulder Dam; Bull Run Watershed trip, including Marmot Dam site; a bicycle tour of City of Portland's green infrastructure; Mount St. Helens; wine country tour; tour of sewage treatment plant on the Tualatin River; Willamette River tours, including wildlife refuge kayaking; Spirit of Portland, which would make a good dinner cruise for Thursday night (May 3); canoe tour in Willamette Harbor area.
    - Action: Local planning committee will decide which field trips will be offered and costs by January when the conference registration site goes online.
    - Action: Local committee will continue to solicit more sponsors.
    - Accomplishments: Local committee has secured an Oregon plenary speaker.
  - Action: Maggie Craig and Dave Mueller will combine all five abstract review team suggestions into a master spreadsheet for the Program Committee to review.
  - ACTION BY COUNCIL: DECIDE on what venue (e.g., special session) to give the broad audience an update Council Products and activities and ask participants for their input.

  - All members send info if your state/region is doing qPCR or pilot studies to Mary.
- 7. Action: Monitoring for Effectiveness of BMPs (Held Over from May 2011 meeting):
  - Council will pursue a more active participation of NRCS: Greg Pettit will contact Shaun McKinney of NRCS National Technology Support Center to explore interest to join the Council. Mike Yurewicz suggested Shaun provide a webinar on their activities so that Council members can be aware of how NRCS could contribute to the Council.
  - Future WIS Call may include:
    - Nancy Mesner, University of Utah (?) Manual for Monitoring for BMP Effectiveness
    - State Models of 319 Monitoring (Webinar Gary, Neil and Jeff).
  - Work more closely with National Nonpoint Source Monitoring Program.

- 9. Action: Water Quality Statistics and Assessments (Doug McLaughlin, Dan Sullivan):
  - WQSA in need of responses and filled out spreadsheets with what works and doesn't.
  - Demonstrate WQSA NEMI at May 2012 Conference
  - Webinar on NEMI for Council
  - Doug will circulate the spreadsheet to the Council by Dec 1; Council will send submission intention to Doug by Dec 9<sup>th</sup>.
