1. For autos in the NIPAs, net purchases also includes reimbursement of government employees for use of personal autos on government business.
2. In the FAAs, nonreplacement items account for about 20 percent of total expenditures in motor vehicle parts and accessories shown in NIPA table 2.4.5, line 7. Nonreplacement items consist of items not included as original equipment on new motor vehicles.
3. Consists of statistical revisions to the NIPAs that have not yet been incorporated into the FAAs.
4. Used autos are valued at acquisition prices less depreciation in the estimates of the stocks of private fixed assets and consumer durable goods; net purchases of used autos by business from consumers are valued at wholesale prices in gross fixed investment.
