The U.S. Jaycees have advised that beginning this year with the 1986 nominees, the Ten Outstanding Young Men awards program has been renamed Ten Outstanding Young Americans and will be open to men and women.

**Issuance Notice:** This UPDATE issue replaces the 7 December 1971 issue of AR 672-6, which should now be discarded.

**Locator Sheets:** Until all publications are converted to the UPDATE format, the sequence of a "library" can be maintained by inserting this publication in the appropriate looseleaf binder where other publications are stored.

**Citations:** In using an UPDATE printing of a publication when making a citation, simply cite the publication.

**Editorial Comments:** This UPDATE publication contains editorial comments that are not in the original standard version. These comments were inserted when there was a need to clarify the placement of an element of text (for example, the location of a referenced table). These comments are set in bold italic type and enclosed in parentheses.

**Placement of Tables, Figures, Appendixes, and "R" Forms:**

- Full page tables, figures and appendixes (in that order) in update publications are located following the last chapter of the related publication. Less than full page tables and figures will be placed when applicable nearest the first cited reference in the related publication.

- All reproducible forms (R forms) included in update publications are located at the back of the volume in numerical sequence beginning with DA Forms.

**A Special Note About Forms and Local Reproduction:** Forms are one of the Army's basic work tools. As the successful use of forms is often closely related to the effective and efficient handling of actions, the following general information about locally reproducible forms may be helpful to you.

- DA locally reproducible forms are designated with the suffix "R" as in DA Form XXX-R.

- The authority for local reproduction of DD Forms and their use is given in the directive.

- Sources for forms not authorized for local reproduction are the AG publications centers or as stated in the authorizing directive. Since these forms may *NOT* be reproduced locally, they must be requisitioned.

- The copies of "R" forms at the back of regulations are for your use in making local reproduction. Have them printed through your Forms Management Officer (FMO). In accordance with AR 310-1, paragraphs 4-26 and 4-28, the FMO may authorize the reproduction of a form in a modified format

more convenient to local users. Those provisions permit back-to-back printing, carbon sets, and continuous construction for word processing use.

- AR 310-1 also authorizes overprinting of locally fixed processing information. The idea behind this authorization to overprint is to reduce the amount of time a typist has to spend repeating "local boiler plate" requirements.

- The rules for procuring printing differ from place-to-place. Therefore, your FMO may not be able to approve the printing. In such a case, the decision to overprint, or not to overprint locally required information, would be taken at the lowest level where printing decisions are made.

The Forms and Local Reproduction program offers you an opportunity to reduce your administrative burden and to save precious manhours for your unit.

**Summary.** This regulation covers the Department of the Army's policy for nominating members of the Army for the U.S. Jaycees Ten Outstanding Young Americans Award.

**Applicability.** This regulation applies to the Active Army, Army National Guard (ARNG), and the U.S. Army Reserve (USAR).

**Impact on New Manning System.** This regulation does not contain information that affects the New Manning System.

**Supplementation.** Supplementation of this regulation and establishment of forms other than DA Forms are prohibited without prior approval from HQDA (DAPC-ALA), ALEX VA 22332-0400.

**Interim changes.** Interim changes to this regulation are not official unless they are authenticated by the Adjutant General. Users will destroy interim changes on their expiration date unless sooner superseded or rescinded.

**Suggested improvements.** The proponent agency of this regulation is the Office of the Deputy Chief of Staff for Personnel. Users are invited to send comments and suggested improvements on DA Form 2028 (Recommended Changes to Publications and Blank Forms) directly to HQDA (DAPC-ALA), ALEX VA 22332-0400.

**1. General**

Each year the Department of the Army nominates one or more members of the Army for America's the Ten Outstanding Young Men Americans award. The award is given annually by the United States Junior Chamber of Commerce to the ten men or women of the nation selected for exceptional achievements that have been significant to their professions, communities, States, or the Nation. Presentation of the award is at the annual Ten Outstanding Young Men Americans Awards Congress, customarily held in mid-January. Nominees under final consideration must indicate a willingness to attend the annual awards ceremony.

**2. Purpose**

The purpose of the program is to focus public attention on the accomplishments of the Nation's young men or women and to illustrate the opportunities for young men or women in a free society through the free enterprise system.

**3. Description**

The award consists of a certificate and a small silver trophy mounted on a solid base, with two vertical hands, fingertip, symbolizing "youth reaching upward to the hands of guidance."

**4. Eligibility**

Men or women between the ages of 2+18 and 35, in any field of endeavor, are eligible for consideration if they do not reach age 36 until after 31 December of the award year and are native born or naturalized citizens of the United States, or have applied for citizenship before 1 January of the award year.

**5. Criteria for selection**

A nominee is selected because he or she has made an exceptional contribution or achievement that is of considerable importance to his or her chosen field or fields, to the State, or Nation.

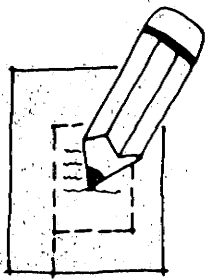
**6. Nomination procedure**

Major Army field commanders, commanders of CONUS armies, and heads of Department of the Army staff agencies will submit nominations or negative reports to HQDA (DAAG-PSA-BC), Washington, DC 20314 HQDA (DAPC-ALA), ALEX, VA, 22332-0400, by 31 May of the award year. Nominations will be prepared on special blanks which can be obtained from the local Junior Chamber of Commerce or from

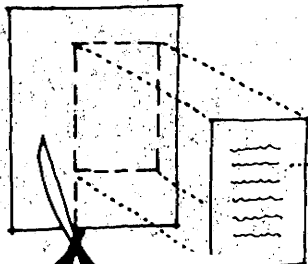
the U.S. Junior Chamber of Commerce, Box 7, Tulsa, OK 74101-0007. All information on the nomination form is to be completed to include the nominee's signature on page 4 5 which attests to the facts shown, gives permission to publish them, and indicates his or her willingness to attend the Awards Congress, if selected. The Awards Congre. pays all travel and expenses. The nomination form also provides a space for the signature of the nominator. This space will be left blank. If selected, an appropriate official at Headquarters, Department of the Army will sign it and send the nomination to the U.S. Junior Chamber of Commerce.

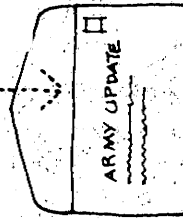
