B. Description of Modification

By means of this modification, the following orders are incorporated:

1. DOE Order 153.1, Departmental Radiological Emergency Response Assets, dated 6-27-2007 is hereby incorporated. This Order applies to all Departmental elements responsible for emergency response. There is no cost or schedule impact to CH2M Hill contract as it is currently practiced (support to a Hanford contractor who has the responsibility of developing, maintaining, operating, and overseeing its own Radiological Assistance Program).
2. DOE N 206.4, Personal Identity Verification, dated 6-20-2007 is hereby incorporated. This Notice applies to all Departmental Elements and to the badging of all DOE Federal employees, all contractor employees with an L or Q access authorization and applicants for employment in the populations described above within all Departmental elements who require a DOE security badge. It is recognized that through the implementation of DOE N 206.4, it will be necessary for all cleared personnel to make additional trips for badging procedures. The cost for additional time and travel for badging is cost reimbursable. There shall be no other cost or schedule impacts through the incorporation of this DOE Notice.
3. DOE O 226.1A, Implementation of Department of Energy Oversight Policy, dated 5-25-2007 is hereby incorporated. This Order cancels DOE O 226.1 and applies to all Departmental Elements and assurance systems implemented by DOE contractors and DOE organizations that manage or operate onsite oversight programs. This Order covers operational aspects such as environment, safety, and health; safeguards and security; cyber security; and emergency management. The implementation of DOE Order 226.1A shall have no cost or schedule impacts.
4. DOE M 231.1-1A, Change 2, Environmental, Safety and Health Reporting Manual, dated 3-19-2004 is hereby incorporated. This Manual provides detailed requirements to supplement DOE O 231.1A, including time schedules for reporting and data elements to be reported. The implementation of DOE M 231.1-1A shall have no cost or schedule impacts.
